#### **Police Department- Patsy Rhett- Councilperson**

Councilperson Rhett stated that Chief Pendarvis would be giving the police department report. Three reports were written for the month. The police department purchased a 2010 Tahoe. The Chief stated that the other vehicles are ready for sale. Councilperson Rhett asked when the vehicles would ready for sale. No answer was given.

#### **Parks-Councilman Michael Void**

Councilman Void stated that the Trunk or Treat was a success. Councilman Void asked a question why the church across the street had an event on the same day as the town. His main concern was safety because he saw children crossing the street. Councilman Void feels that there should be meeting to discuss future events and conflicting date and time. The Nature Park has some future enhancements going on that's plan for the future. The first phase is the bridge. Second question was concerning the Bowman Fire Truck not being on site.

#### **Streets - Councilman Weathers (Absent)**

Councilman Weathers was absent. Mayor Glenn stated that we are getting closer to the street enhancement. The SCDOT has begun to put sticks out. Mayor Glenn stated that the town has a new Economic Development Board in place. The board doesn't have any voting power but they have extra eyes to help improve. Mayor Glenn stated that the trees have been removed. The roof is slated to be replaced the rain has been the delay. Mayor Glenn stated that we may be getting someone to sell fresh fruits.

#### **Old Business**

Mayor Glenn spoke about the recovery act. Monies would be deducted from income for past due debt. The debt set off received its final reading, along with the recovery collection.
