### **Parks-Councilman Michael Void**

Councilman Void stated after the teams are formed they would look into fundraisers towards providing uniforms and etc. for the team.

He furthered stated that he is still looking into an inside lock for the restroom in the Inner City Park and getting signage posted in the park referring to the garbage and no smoking.
