

MINUTES OF MARCH 4, 2025  
BOWMAN TOWN COUNCIL MEETING

THE REGULAR MONTHLY MEETING OF THE TOWN TOWN COUNCIL WAS CALLED TO ORDER AT 7PM BY MAYOR PATSY F. RHETT. COUNCILMEMBERS, ROGERS, GLENN AND CARTER WERE IN ATTENDANCE AND COUNCILPERSON SMITH WAS ABSENT. THE AGENDA SERVED AS THE ORDER OF BUSINESS FOR THE MEETING.

THE PRAYER WAS MADE BY COUNCILMAN CARTER AND THE PLEDGE LED BY COUNCILMAN GLENN. MAYOR RHETT ASKED FOR A MOTION TO APPROVE THE FEBRUARY MEETING MINUTES, MOTION MADE BY COUNCILPERSON ROGERS AND SECOND BY COUNCILMAN GLENN. MOTION PASSED. MAYOR RHETT THEN ADVISED THE COUNCIL THAT THE FINANCE REPORT WOULD BE SENT TO THEM AT A LATER DATE DUE TO COMPUTER PROBLEMS.

NEXT, MAYOR RHETT THEN ASKED FOR A MOTION FOR EXECUTIVE SESSION TO HEAR FROM THE AUDITOR FROM THE BRITTINGHAM GROUP. MOTION MADE AND CARRIED. MS. JESSICA BERRY FROM THE BRITTINGHAM GROUP THEN ADDRESSED THE COUNCIL. AFTER QUESTIONS AND ANSWERS, MS. BERRY TOLD THE GROUP THAT THE AUDIT WAS COMPLETE.

THE MEETING WAS THEN CALLED BACK INTO SESSION WITH THE FOLLOWING TAKING PLACE:

1. COUNCIL APPROVED REQUEST FROM TAMIKA HODGES TO PERFORM A SURVEY OF THE RESIDENTS OF THE TOWN WITH REGARDS TO THINGS THE RESIDENTS WANTED TO SEE IMPLEMENTED IN THE TOWN.
2. COUNCIL HEARD FROM MRS. FOBBS AND APPROVED HER REQUEST FOR A SPRING FESTIVAL TO BE HELD IN THE TOWN ON JUNE 28<sup>TH</sup>, 2025 FROM 10AM TO 9PM. FINAL DETAILS WILL BE WORKED OUT AND PROCESSED THRU THE NECESSARY CHANNELS.
3. LETTER FROM DOT RELINQUISHING RESPONSIBILITY FOR THE DRIVEWAY AROUND THE MEDICAL CENTER WAS PUBLISHED.

4. MAYOR RHETT THEN ASKED COUNCIL TO SIGN THE TOWN'S PROCUREMENT PROCESS. DOCUMENT SIGNED BY ALL IN ATTENDANCE (see attached)

REPORTS WERE THEN MADE WITH REGARDS TO THE FOLLOWING DEPARTMENTS:

WATER AND SEWER, COUNCILPERSON GLENN

STREETS, COUNCILMAN CARTER

POLICE, COUNCILPERSON ROGERS

AFTER A BRIEF DISCUSSION WITH PERSONS IN ATTENDANCE, MAYOR RHETT THEN ASKED FOR A MOTION TO DISMISS. MOTION WAS MADE AND PASSED BY THE COUNCIL AND THE MEETING WAS ADJOURNED.
