ORDINANCE # 1B -2025-7-1

AMENDMENT TO SEWER ORDINANCE
TOWN OF BOWMAN

Be it ordained that the Town of Bowman Sewer Ordinance be amended to reflect the following changes: All citizens with a home or business located on the streets of Bowman or where there is an operational sewer line must connect to the Town of Bowman's sewer system. The in-town basic flat rate will be \$20.50 (per 2500 gallons) with additional usage of .30 cents per one hundred (100) gallons and commercial in-town flat rate will be \$23.00 per 2500 gallons and commercial out-of-town flat rate will be \$23.00 per 3000 gallons with additional usage of .38 cents per one hundred (100) gallons upon signing of this ordinance. The above rates will become effective March 1, 2025.

AMENDMENT TO WATER ORDINANCE
TOWN OF BOWMAN

Be it ordained that the Town of Bowman Water Ordinance be amended to reflect the following changes: All citizens with a home or business located on the streets of Bowman or where there is an operational water line must connect to the Town of Bowman's water system. The in-town basic flat rate will be \$18.50 (per 2500 gallons) and out-of-town the basic flat rate will be \$19.50 per 3000 gallons upon signing of this ordinance. Additional usage above the flat rate will be calculated at .38 cents per one hundred (100) gallons. The above rates will become effective March 1, 2025.
