THE REGULAR MONTHLY MEETING OF THE TOWN COUNCIL WAS CALLED TO ORDER AT 7PM ON JUNE 2, 2026 BY MAYOR PATSY RHETT. COUNCILMAN JOHNSON, COUNCILPERSON PELZER, COUNCILPERSON SMITH, COUNCILPERSON ROGERS WERE IN ATTENDANCE.
